



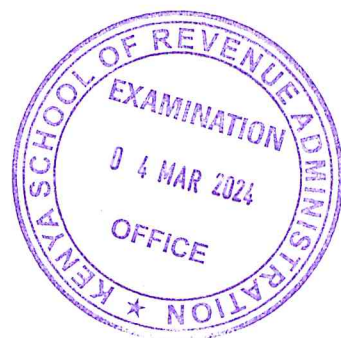
EXAMINATION RULES AND REGULATIONS

- All answers should be written on the official answer booklet provided.
- Each question should be answered on a separate sheet of paper.
- Answer all questions in **English**
- Candidates should remain in the examination room throughout the examination period.
- Indicate only your **Admission Number** on each answer sheet.
- Ensure that you have signed the exam attendance register before leaving exam room.
- Cell phones, laptops, Smart watches, ear pods and similar electronic gadgets are **NOT** allowed in the examination room.
- Detection of any cheating shall lead to automatic disqualification.
- Each student is required to carry with them into the examination room their Examination card and student Identification card. No student shall be allowed into the examination room without the identification documents stated.
- No books, bags, notes and any revision material should be taken by the students to the examination room.



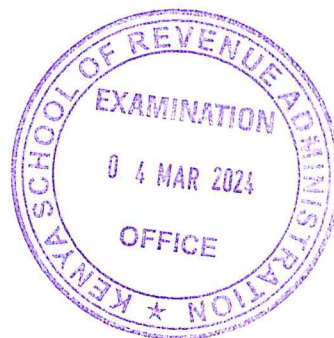


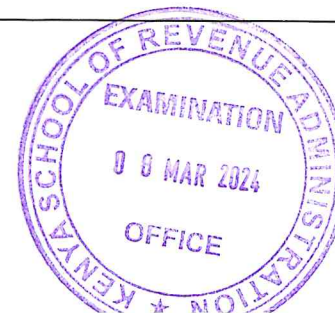
